Constanta Chamber of Commerce, Industry, Shipping and Agriculture/Romania and Chamber of Commerce and Industry in Karabuk/Turkey hereinafter called "Parties".

*Considering the mutual interests in favouring the contacts and relationships of co-operation between companies, organizations and entrepreneurs of both parties,

*With the intention of enlarging, developing and carrying out co-operation action which are mutually favourable between the Turkish companies in the city of Karabuk/Turkey and the companies in the city of Constanta / Romania have signed this agreement:

Article 2

The parties shall provide the associations, companies, firms and organizations of the above-mentioned areas with assistance in order to strengthen business contacts and, in particular, research of potential partners in the trade, industrial ,technical and scientific fields. The parties will work in co-operation in order to develop the business relationship in terms of small-and medium-sized firms.

The Parties shall exchange information on exhibitions, shows, meetings, workshops and other initiatives which will take place in both areas and in which national and foreign entrepreneurs will take part, informing the members of the two bodies.

Article 4

Both Parties, within their capabilities, shall provide the necessary information in the field of organizing workshops and meetings along with functioning of small-sized firms.

Article 5

The Parties intend to take part in working out and drawing up joint plans, organizing trade missions, shows, exhibitions as well as business meetings in order to inform the entrepreneurs about the possibilities of exports in both countries.

The Parties shall organize and promote the exchange of business delegations.

Article 6

The Parties shall keep in touch and, if necessary, hold meetings annually in the two countries in order to exchange business ideas and experiences.

Article 7

In case of any commercial disputes Constanta Chamber of Commerce, Industry, Shipping and Agriculture/Romania and Karabuk Chamber of Commerce and Industry/Turkey will also follow up with their members to resolve and settle such disputes amicably.
